### PURPOSE & SCOPE

## <u>Purpose</u>

➤ To issue policies and standards to aid in the prevention of sexual assault throughout the Navy, provide support to victims, define requirements, and assign responsibility for implementation of the Navy Sexual Assault Prevention and Response (SAPR) Program

## <u>Scope</u>

All Navy personnel are responsible for understanding Navy's sexual assault policy, the penalties and consequences for engaging in any form of sexual assault, and the adverse impact of sexual assault on unit and Navy mission accomplishment

### RESPONSIBILITIES

#### > OJAG:

- Provide advice, instruction and guidance regarding the legal aspects of sexual assaults and responder training

#### > **CNO**:

- Ensure that policy, guidance and actions support the Navy's SAPR program objectives and meet command, service member and victim needs

#### > Chief, Bureau of Medicine & Surgery (BUMED):

- Maintain confidentiality of medical information for both restricted and unrestricted reports

#### > Commander, Navy Personnel Command (NAVPERSCOM):

- Ensure all ADSEP actions involving victims of sexual assault are reviewed and they receive full and fair consideration of their military service.

#### Commander, Navy Installations Command (CNIC):

- Manage, implement and oversee the installation of the SAPR program UNCLASSIFIED//FOUO

## RESPONSIBILITIES

#### > Regional Commanders:

Issues guidance to installation COs for management and implementation of the Navy SAPR program

#### Installation COs:

Ensure Service members, their family members, and civilian personnel have access to a well-coordinated, highly responsive SAPR program and appropriate resources

#### SAPR Officers:

Serves as a liaison between subordinate commands and CoC regarding all aspects of the SAPR program

#### Regional Sexual Assault Response Coordinator (SARC):

Subject matter experts and POCs for their assigned region. Must complete 40 hours of training.

#### SAPR VAs & Unit SAPR VAs:

Primary means of ongoing support to the victim and the primary liaison between the victim and command leadership

## REPORTING OPTIONS AND REQUIREMENTS

## Restricted reporting:

- The restricted reporting option does NOT trigger an investigation and is only available to Service members and adult military dependents. Restricted reporting allows Service members and military dependents who are over 18 years of age to confidentially disclose the assault to specified individuals (e.g., SARC, deployed resiliency counselor, SAPR VA, unit SAPR VA, victims' legal counsel, or healthcare personnel) and receive healthcare treatment and the assignment of a SARC, deployed resiliency counselor, SAPR VA, unit SAPR VA, and victims' legal counsel. A victim may change a restricted report to an unrestricted report.
- DSAID DD Form 2965 must be completed (http://www.esd.whs.mil/Portals/54/Documents/DD/forms/dd/dd2965.pdf)

## REPORTING OPTIONS AND REQUIREMENTS

## **Unrestricted reporting:**

- Triggers an official investigation of the allegations, command notification, VWAP rights and additional command protective actions, and allows eligible sexual assault victims access to medical treatment, legal services, and counseling
- Upon the victim's election of unrestricted reporting via the DD Form 2910

(http://www.esd.whs.mil/Portals/54/Documents/DD/forms/dd/dd2965.pdf), SARCs must notify the installation CO and victim's CO within 24 hours of the report. This notification may be extended by the CO to 48 hours after the unrestricted report of the incident when there are extenuating circumstances in deployed environments. A victim may not change an unrestricted report to a restricted report

## REPORTING OPTIONS AND REQUIREMENTS

- Personnel incident reports (i.e., OPREP-3 NAVY BLUE, OPREP-3 NAVY UNIT SITREP) must be submitted
- An OPNAV 1752/2
   (<a href="https://navalforms.documentservices.dla.mil/formsDir/\_OPNAV\_1752\_2\_13941.pdf">https://navalforms.documentservices.dla.mil/formsDir/\_OPNAV\_1752\_2\_13941.pdf</a>)
   must be submitted within 8 days of the command becoming aware of a report or investigation of an adult sexual assault involving a Service member victim or a Service member alleged offender
