
THE PURPOSE

- Reports the offense(s)
- Records that the accused has been advised of their rights under Article 31, UCMJ
- Can serve as a preliminary inquiry report
- Records the action of the XO at screening hearing




THE PURPOSE

- Records that the accused has been advised of the right to refuse NJP
- Shows the action of the CO at mast
- Records that appeal rights have been explained to the accused
- Becomes a permanent record of the case in the Unit Punishment Book



Front Side

- Person submitting report (LN) sending to NJP authority
- SSN use allowed on legal documents
- May be multiple places and dates of offenses





- Witnesses ordered by seniority
 - Civilians?
- > LN usually submits report

DETAILS OF OFFENSE(S) (Refer by Article of UCMJ if known. If unauthorized absence, give following info: time and date of commencement, whether over leave or liberty, time and date of apprehension or surrender and arrival on board, loss of ID card and/or liberty card, etc.):

Charge: Violation of the UCMJ, Article 91

Specification: In that Logistics Specialist Seaman John C. Doe, U.S. Navy, USS UNDERWAY, on active duty, on board USS UNDERWAY, located at Norfolk, Virginia, on or about 25 July 2014, was disrespectful in language toward Logistics Specialist First Class Shirley Temple, U.S. Navy, a petty officer, then known by the said Logistics Specialist Seaman John C. Doe, U.S. Navy, to be a superior petty officer, who was then in the execution of her office, by saying to her, "You are an idiot," or words to that effect.





 - Witnessed by LN





Information Concerning Accused

- Only use what is officially reflected in accused's Electronic Service Record (ESR)
- Look for Page 7s, Page 13s, and awards info for any previous NJPs/courts-martial/ civilian convictions
 - May have to coordinate with previous command

 - PI Officer makes recommendation to CO



- Right to demand trial
 - SHORE DUTY ONLY
 - "Demand"
 - Ensure accused circles IAW preference


RIGHT TO DEMAND TRIAL BY COURT-MARTIAL




Action by CO

- CO signature!







REVIEW

- T/F Appeal notification is required for every NJP case with a guilty finding.
- What is the report chit form number?
- ➤ T/F The date of the report chit is the date the allegation(s) was/were reported.
- Where are report chits filed upon completion of NJP?
- ➤ T/F An accused is required to acknowledge the nature of the accusation(s). Is there an exception?



REVIEW

- How do you list the witnesses on the report chit?
- T/F The right to demand trial by court-martial is required to be signed by the accused.
- On the report chit, where would you indicate that an accused appeared before the XO? DRB?
- In calculating an accused's pay per month, what types of "pay" do we use?
- ➤ T/F Every report chit generated (including dismissed cases) is required to be filed in the unit punishment book.
